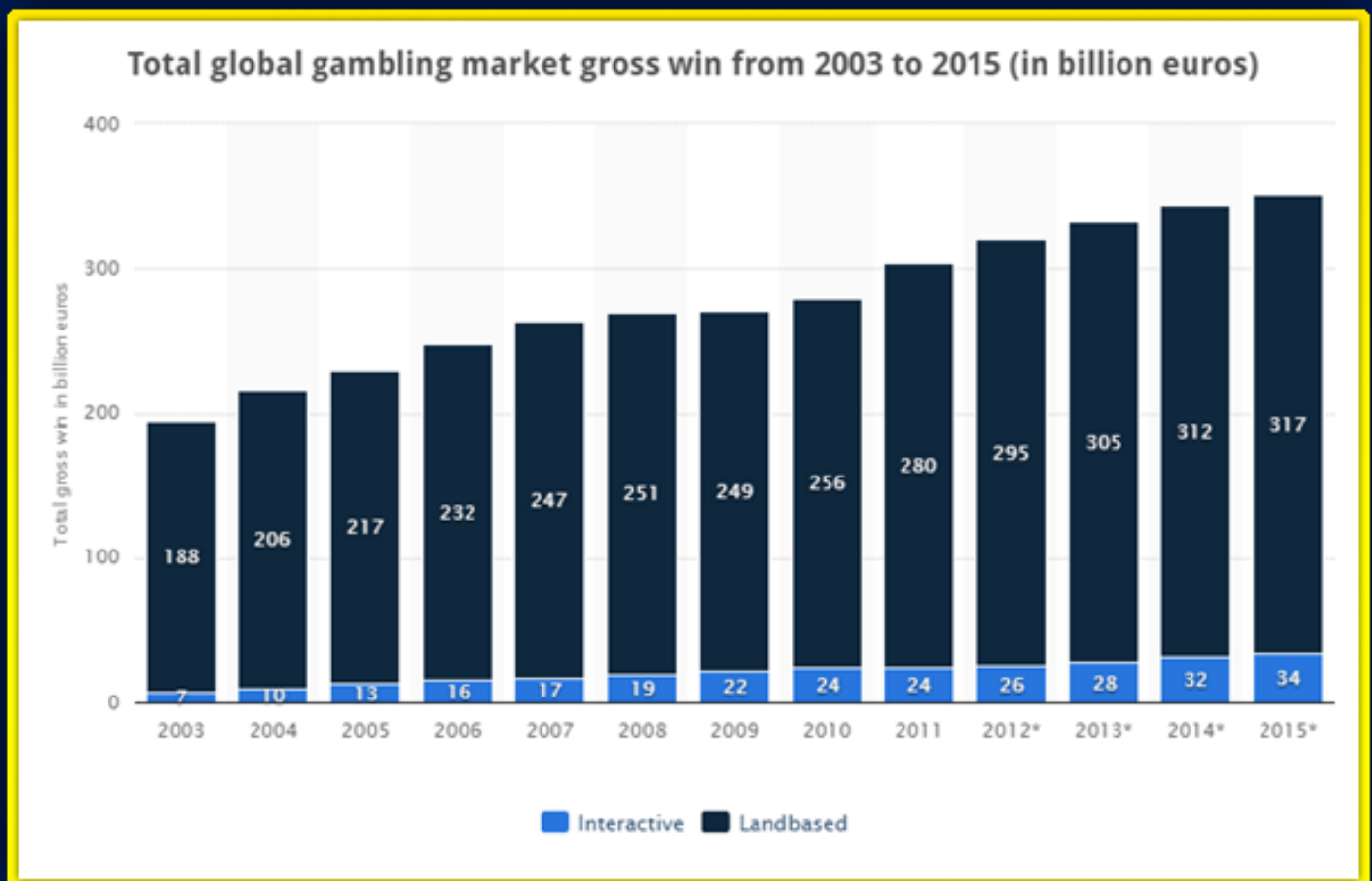

- **Fastbet** is a project of an online, anonymous and secure casino available from anywhere on earth around the clock! No identity verification, no fees for using the platform, low commissions, full anonymity are just a few of the features that distinguish our platform! The idea for the project was created at the beginning of 2018 to be able to fully play anonymous gambling games.

- Let's just look at how the gambling market in the world is growing. Fastbet will be a place where everyone can play regardless of his nationality! The casino will be based on popular cryptocurrencies and a unique FBET token, so as to fully ensure the anonymity of the transaction!

Why ico?

Why do we collect funds using our own FBET token?

- The cost of creating a safe and unique casino is huge, we are not able to provide all gambling functions with our own resources. At the same time, prizes in the form of a monthly casino payment are waiting for FBET tokens holders. Funds collected from the pre-ico phase will be used to develop security and to create a beta version of the casino. We will allocate funds from the ICO phase to adding new opportunities and ensuring full anonymity for users of our platform.

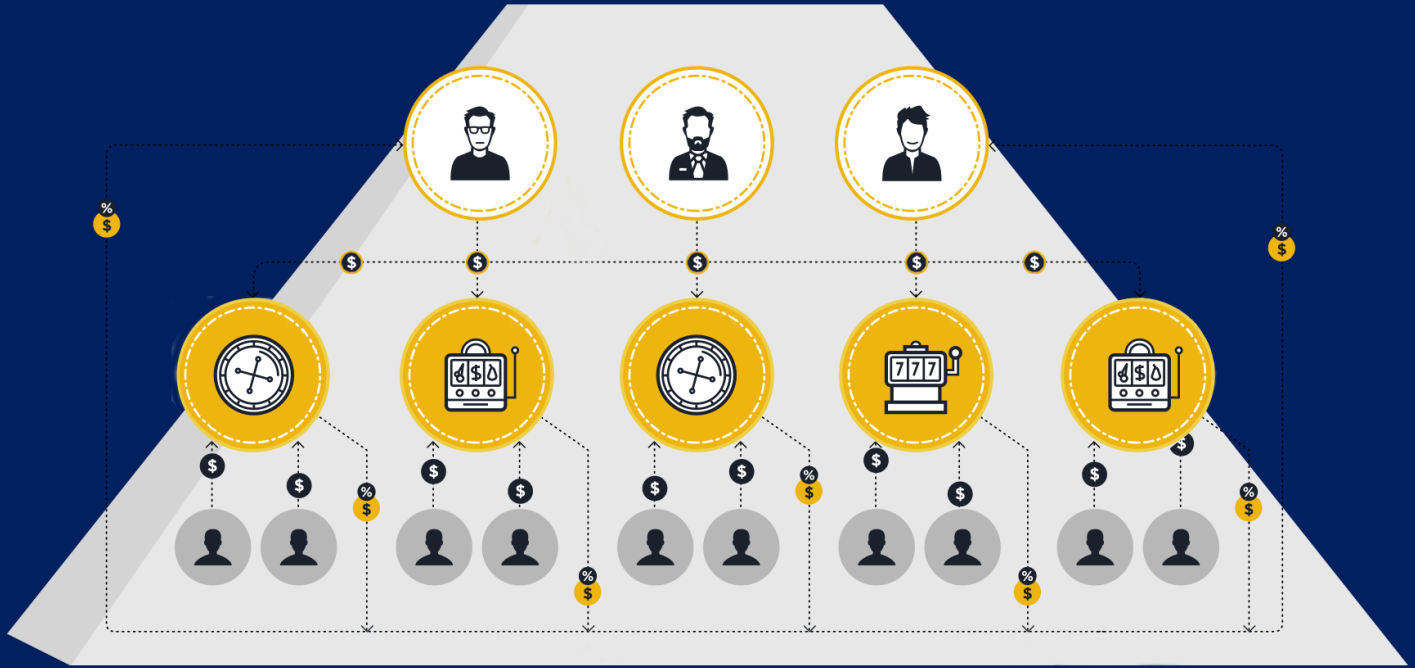
We're constantly working on adding new payments so that they're comfortable for everyone!

Token Holders Benefits

- The first and most important benefit for having a FBET token is a monthly casino fee paid according to your FBET tokens.
- After the official opening of the casino (after the ico phase), a special program will be launched, which will provide all the owners with an appropriate remuneration. 50% of the casino's earnings will be distributed every month to holders of tokens.
- For example: If the casino earns 100 ETH in the first month and you have 1% of issued tokens, you will receive a commission for your portfolio of 1ETH. Yes - the commission will be paid in Ethereum, not in tokens.
- The exact dates of the commission payment will be given after the ICO phase. Remember that in order to receive a commission you will need to have the tokens in your ERC-20 wallet.
- No commission will be paid to the exchange accounts and FBET project administrators.
